UNLAWFUL

For any person to engage in the business or act in the capacity of a PUBLIC WORKS CONTRACTOR in the State if Idaho without a license.

PENALTIES

Any person, firm, co-partnership, or corporation, acting as a PUBLIC WORKS CONTRACTOR without a license shall be guilty of a MISDEMEANOR.

EVERY PUBLIC OFFICER who knowingly lets a public contract to any person, firm, co-partnership, or corporation, who does not hold a license shall be guilty of a MISDEMEANOR.

EXCEPTION

No contractor shall be required to have a license in order to submit a bid or proposal for contracts for public works FINANCED IN WHOLE OR IN PART BY FEDERAL AID FUNDS, but at or prior to the award and execution of any such contract by the State of Idaho, or other contracting authority the successful bidder shall secure a license.

WHO MUST BE LICENSED

"Public works contractors," — which is any "builder," or "specialty contractor," or any person who offers to submit a proposal or enter into a contract with the STATE OF IDAHO, or and COUNTY, CITY, TOWN, VILLAGE, SCHOOL DISTRICT, IRRIGATION DISTRICT, DRAINAGE DISTRICT, SEWER DISTRICT, FIRE DISTRICT, or any other taxing subdivision or district of the State, authorities to let or award contracts for the construction, repair or reconstruction of any public work.

SUPPLY ONLY BID PACKAGES
