Item G2 The Construction Period of 120 calendar days as identified by the Construction Documents is applicable to the interior work as shown on the drawings and will establish a Partial Substantial Completion date to allow Owner occupancy. Liquidated damages will be applicable to this Partial Substantial Completion.

The exterior site work as shown on Drawing A0.1 will proceed on or before April 15th, 2020 and completing the exterior site work by May 13th, 2020. This establishes the Substantial Completion for the total project, including warranties as May 13th, 2020.

ARCHITECTURAL ITEMS:

- Item A1 At Drawing A0.1, delete Keyed Note #1 and all Work shown with that note.

- Item A2 At Drawing A0.1, remove existing irrigation time clock and provide two (2) new time clocks with the number of zones to total four (4) more than existing. Coordinate with SGT Joe Gonzalez at (208) 757-9703.
